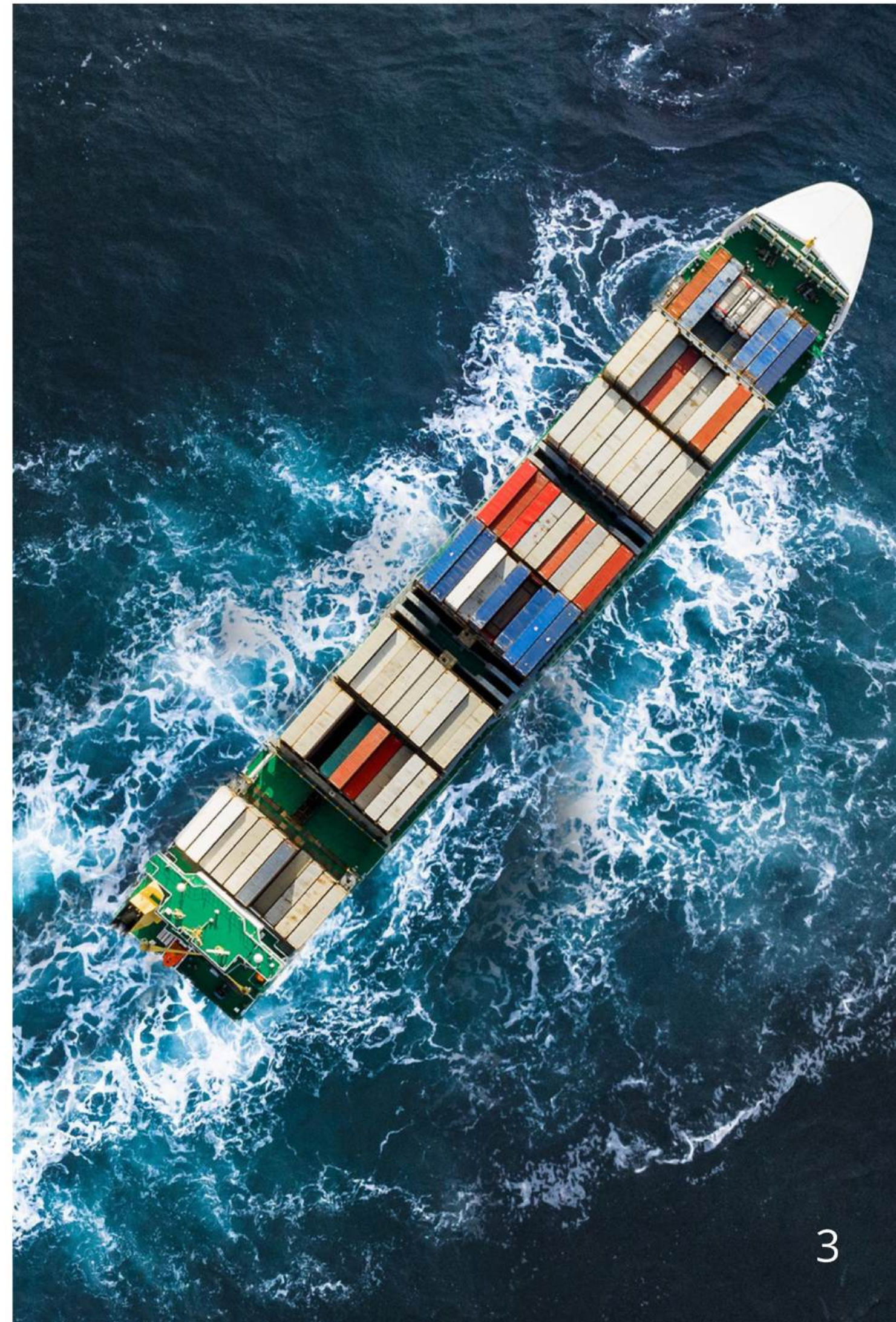

DOCUMENTS REQUIRED FOR SHIP REGISTRATION

TO REGISTER YOUR VESSEL, THE FOLLOWING DOCUMENTATION IS TYPICALLY REQUIRED

- Completed application form for ship registration.
- Declaration of eligibility to register the vessel. Original
- Bill of Sale proving ownership. Survey and tonnage
- measurement certificate. Incorporation certificate (if
- owned by a company). Extract of register and deletion
- certificate (if applicable). Tonnage certificate or
- certificate of survey with a closed transcript. Notarized
- translations of foreign-language documents, certified as
- correct by a notary public.

Additional documents may be required based on the country of origin or specific circumstances.
